Notification

Bombay Lifts Act; 1939

No. BLA -2008/CR-78/Energy 1. —In exercise of the powers conferred by clause (fa) of sub-section (2) of section 12 of the Bombay Lifts Act, 1939 (Bom. X of 1939), and of all other powers enabling it in that behalf, the Government of Maharashtra hereby makes the following rules further to amend the. Bombay Lifts Rules, 1953, the same having been previously published as required by sub-section (I) of the said section 12, namely: —

- 1. i) These rules may be called as the Bombay Lifts (Amendment). Rule 2010.
 - ii) They shall come into force with effect from the 1st February, 2010
- i) As per clauses in the notification fees for preliminary inspection shall be paid in advance with application as per scale A (3) & Annual inspection fee shall be paid as per scale A (4) at the time of inspection.
 - ii) For issuing license to lift contractor license fees shall be paid as per scale B

- iii) For issuing duplicate copy of license and change in name fees shall be paid as per scale C
- iv) Inspection fees shall be paid by the user or applicant.
- v) Inspection fees shall be paid to government directly or through electrical Inspector office in cash or through local bank cheque or through demand Draft. Charges for clearance of Demand Draft shall be paid by user or applicant
- vi) If user / applicant fails to compliance of remarks if any, the said lift shall be treated as unauthorized. In that case User/ Applicant will not be allowed to operate the lift.
- vii) Frequency of periodical inspection shall be decided by the Government of Maharashtra. Inspection Fees should be charged as per the provisions of the Act for regular inspection, examination, tests etc. In case of a second or subsequent inspections within a period of twelve months from the date of first inspection, examination or test, fee shall be levied as under: -
 - (a) Fees at one half of the said rates shall be levied if, in the opinion of the electrical inspector, such inspection, examination or test is necessitated by the neglect or failure of the licensee or owner to carry out within a stipulated time any written order of the Electrical Inspector or by breach of any of the provisions of the act or of the Rules there under
 - (b) No fees shall be levied if such inspection, examination or test is not necessitated by such neglect or failure.

Scale A: - Fees for initial and periodical inspections.

 In the Bombay Lifts Rules, 1958 (hereinafter referred to as "the principal rules") for rule 5-A, the following shall be substituted, namely: —

"5-A. Fees for Licensees - Fees for license for permission to operate the lift shall be paid as follows, namely: -

 (a) For a lift driven by A. C. electric motor (b) For a lift other than a gearless lift driven by D. C. electric Motor (c) For a gearless lift 	Rs. 2,000.00 Rs. 5,000.00 Rs. 7,000.00	

4. For rule 9A of the principal rules, the following shall be substituted, namely: -

"9-A Fees for inspection of lifts: - For the periodical inspection, examination & tests made in accordance with the provisions under Bombay Lift Act, 1939 fees shall be paid either prior to inspection or within ten days from the date of inspection as follows, namely: --

(a) For a lift driven by A.C. electric motor	PerLitt	
	Rs.	600.00
(b) For a lift other than a gearless lift driven by D.C. electric Motor	Rs.	900.00
(c) For a gearless lift	Rs.	1, 500.00

Note: Above scale A rates are for the lifts up to 10 floors. For each additional 10 floors or part thereof, fees will be charged 20% extra of Scale A

Scale B: - Fees for issuing license to lift contractor.

For issuing License to lift contractors, for erection of new lifts & maintenance of lift, following fees shall be levied.

(a) Permission for lift license upto 100 lifts	Rs.	1000.00
(b) Permission for lift license from 101 to 200 lifts	Rs.	2000.00
(c) Permission for lift license above 201 lifts	Rs.	5000.00

Note: - For issuing license to new lift Contractors fees shall be levied as above

Scale C: - Fees for issuing duplicate certificate and change in name.

 For issuing duplicate copy of license for operation of lifts and change in name of contractor following fee shall be levied
 Rs. 100.00
